**1. Meeting called to order** at 7.00 pm by Senior Vice President – Air Vice Marshal Dilshan Wasage ( Retd).

**5. Confirmation of the Minutes of the Previous Meeting held on 7<sup>th</sup> September, 2023**

The last meeting minutes were proposed by Eng. R B M Gunawardane as correct and seconded by Mr. Hemantha De Silva.

## **6. Matters arising from Previous Meeting Minutes:**

### **a. Fund Raiser**

Subcommittee Chairperson Mr. Iman Perera informed that proposal could not be made yet & will be submitted to the next Ex-Co meeting.

### **b. Annual Trip**

Subcommittee Chairperson – Eng. Palitha Hendarahewa informed that 26 personnel have paid advance & 5 personnel confirmed verbally. Further he informed that 45 seater may be available for the same cost & could confirm on Monday. He informed that Bus cannot be taken to Non Perial & vans to be utilized for the transport.

### **c. Digital Media & Communication**

Subcommittee member Mr. Shammi Uyanage informed that contact list of Past Teachers, uploaded to the website. Further he has informed that details of Trust up to 2022 which was screened by Mr. Susuri De Silva also uploaded to the web site.

Subcommittee member Eng. Damindra De Silva informed that A Mobile App has been developed to get data & information from DCPA members to the DCPA Web site and to share information quickly. App was submitted to the “Google Play store” for the approval & it will take 2 weeks. It is named as “Damso Colombo” App. There are 4 main areas – Obituary Notice, News Feeds, Introduce Member and Past Teachers in the App. Any member can up load data to the particular area in order to receive by the Admin & Admin will post it to DCPA – CB website if appropriate. This will be a tool for the Membership Drive committee too.

It was noted that Eng. Damindra De Silva has organized advertisements worth of Rs. 50,000/= for the website. Requested all other Ex-Co members also to find advertisements even in a small scale.

Chairman of the Trust – Eng. Lal Premanath requested to up load Scholarship Request Letter to Prospects and Remittance Advice which will be arranged by him, to the DCPA Colombo web site in order to obtain more scholarships specially from members staying overseas.

**d. Sports Activities**

- Indoor Cricket Net which was donated by Mr. Dinesh Chandimal was handed over to school on 1<sup>st</sup> October 2023.

**e. Felicitation Ceremony for Mrs. Kushani Rohanadeera**

It was noted that the over expenditure of Rs. 63,906/= in respect of the Felicitation Ceremony, could not be covered with the money collected amounting to Rs. 159,600/= by the Ex-co Members for the Sokians Fiesta, as approved at the previous Ex-Co meeting.

Mr. Hematha De Silva informed President that he will donate Rs. 20,000/= to cover the expense when he get to know about the ruling / status. President announced that he will bear the balance amount of Rs. 43,906/=. Ex-Co members didn't agree bearing the cost by both of them.

Then suggested to revoke the earlier Ex-Co decision of keeping the money collected amounting to Rs. 159,600/= by the Ex-co Members for the Sokians Fiesta in a separate Fixed Deposit in order to use for a similar event & use it to cover the deficit. But it was not accepted by the majority of Ex-Co members as it is not ethical. Finally, it was decided to cover the deficit by contributing Ex-Co members voluntarily.

**f. Physical Infrastructure**

Subcommittee Chairperson – Eng. R B M Gunawardana informed that they could not visit the school as promised but are planning to visit the school ASAP in order to submit a proposal. It was advised to concentrate on areas which government will not provide assistance. It was informed that Eng. Chandralal Sooriyaarachchi has volunteered to provide transport.

**g. Membership Drive**

It was noted that only 400+ members are contactable even though 1000+ members are in the membership directory. Subcommittee to find a way of increasing the contactability.

It was noted that so many Group activities (year basis) are happening among sokians & need to tap them for memberships. It was suggested that hosting of Ex-Co meeting could be assigned to these groups to impress them.

#### **10. Accounts for the last month**

The Treasurer- Mr. Harish Guruge tabled the monthly accounts for the month of September 2023.

He informed that there 2 receivables; Rs. 25,000/= from BOC for the sponsorship given for AGM & Rs. 15,000/= from the OBA, Ambalangoda for sale of Ties.
